
I am transmitting the following Congressional Act, which I have signed into Public Law No. 22-154:



AN ACT

To appropriate the sum of \$1,105,000 from the General Fund of the Federated States of Micronesia for fiscal year ending September 30, 2022, for the purpose of funding the CIA's Y12 aircraft engine repairs and assembly, freight and other related costs, the FSMTCC – Open Access Entity (OAE), the Education Task Force for the constitutional amendments proposed by the Constitutional Convention and the operation of Xavier High School affected by Covid-19 travel restrictions in Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. The sum of \$1,105,000, or so much thereof as may  
2 be necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for fiscal year ending September  
4 30, 2022, for the purpose of funding the CIA's Y12 aircraft engine  
5 repairs and assembly, freight and other related costs, the FSMTCC  
6 – Open Access Entity (OAE), and the Education Task Force for the  
7 constitutional amendments proposed by the Constitutional  
8 Convention, and the operation of Xavier High School affected by  
9 Covid-19 travel restriction in Chuuk. The funds appropriated under  
10 this section shall be apportioned as follows:

11           (1) CIA's Y12 aircraft engine repairs and assembly,	
12 freight and other related costs .....	\$       455,000
13           (2) FSMTCC – Open Access Entity (OAE) .....	250,000
14           (3) Education Task Force for the constitutional	
15 amendments proposed by the Constitutional Convention	300,000
16           (4) Operation of Xavier High School under Covid-19	

1 Travel restrictions — Chuuk ..... \$ 100,000

2 Section 2. Allotment and management of funds and lapse date.

3 All funds appropriated by this act shall be allotted, managed,  
4 administered and accounted for in accordance with applicable laws,  
5 including, but not limited to, the Financial Management Act of 1979.

6 The allottee shall be responsible for ensuring that these funds, or  
7 so much thereof as may be necessary, are used solely for the purpose  
8 specified in this act, and that no obligations are incurred in

9 excess of the sum appropriated. The allottee of the funds

10 appropriated under Section 1(1) of this act shall be the Secretary  
11 of the Department of Transportation, Communications and

12 Infrastructure or his designee. The allottee of the funds

13 appropriated under Sections 1(2) - 1(4) of this act shall be the

14 President of the Federated States of Micronesia. The authority of  
15 the allottee to obligate funds appropriated by this act shall lapse  
16 on September 30, 2023."
