AN ACT

To amend Public Law No. 22-89, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated therein to fund priority infrastructure projects for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 22-89 is hereby
2 amended to read as follows:

3 "Section 1. The sum of \$400,000, or so much thereof as
4 may be necessary, is hereby appropriated from the General
5 Fund of the Federated States of Micronesia for the fiscal
6 year ending September 30, 2022, to provide supplemental
7 funding for priority infrastructure projects for the
8 people of Yap State. The funds appropriated under this
9 section shall be apportioned as follows:

10 (1) State of Yap.....\$ 400,000

11 (a) Telecommunication and Internet Services

12 Connectivity/Improvement on Satawal, Woleai

13 atoll, Fais and Ulithi atoll. 400,000"


14 Section 2. Section 2 of Public Law No. 22-89 is hereby
15 amended to read as follows:

16 "Section 2. Allotment and management of funds and lapse
17 date. All funds appropriated by this act shall be
18 allotted, managed, administered and accounted for in

1 accordance with applicable laws, including, but not
2 limited to, the Financial Management Act of 1979. The
3 allottee shall be responsible for ensuring that these
4 funds, or so much thereof as may be necessary, are used
5 solely for the purpose specified in this act, and that no
6 obligations are incurred in excess of the sum
7 appropriated. The allottee of the funds appropriated
8 under section 1 of this act shall be the President of the
9 Federated States of Micronesia or his designee. The
10 authority of the allottee to obligate funds appropriated
11 by this act shall lapse on September 30, 2024."

12 Section 3. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.
