

CONGRESSIONAL BILL NO. 22-35

AN ACT

To further amend Public Law No. 20-151, as amended by Public Laws Nos. 20-165, 21-73 and 21-121, by amending section 1 thereof, to change the use of certain funds previously appropriated therein, to fund public projects and social programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 20-151, as amended by
2 Public Laws Nos. 20-165, 21-73 and 21-121, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$600,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the
7 fiscal year ending September 30, 2019, for the purpose
8 of funding public projects and social programs in the
9 state of Chuuk. The funds appropriated under this
10 section shall be apportioned as follows:
