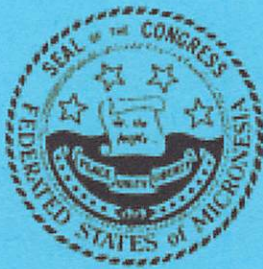

CONGRESSIONAL BILL NO. 22-05, C.D.1

AN ACT

To further amend Public Law No. 18-117, as amended by Public Laws Nos. 18-120, 19-04, 19-08, 19-35, 19-49, 19-59, 19-76, 19-102, 20-26, 20-117, 21-27, 21-114 and 21-166, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-117, as amended by
2 Public Laws Nos. 18-120, 19-04, 19-08, 19-35 and 19-102, is hereby
3 further amended to read as follows:

4 "Section 4. Of the sum of \$2,800,000 appropriated
5 by this act, \$800,000 is apportioned for Pohnpei
6 State for public projects and social programs.

1 Section 2. Section 6 of Public Law No. 18-117, as amended by
2 Public Laws Nos. 19-04, 19-59, 19-102, 20-26, 20-117, 21-27 and
3 21-166, is hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State; PROVIDED THAT, the allottee of funds appropriated
16 under subsection 2(i) shall be the President of COM-FSM.
17 The allottee of funds appropriated under sections 3 and 4
18 of this act shall be the President of the Federated
19 States of Micronesia or his designee, PROVIDED THAT, the
20 allottee of funds appropriated under sections
21 3(a)(b)(c)(d)(e)(f)(g)(h)(i)(j)(k)(l) and (m) shall be
22 the Mayor of Lelu Town Government; the allottee of funds
23 appropriated under subsections 4(1) and 4(2)(i) of this
24 act shall be the Secretary of the Department of
25 Transportation, Communications and Infrastructure or his

1 designee; the allottee of funds appropriation under
2 sections 4(3)(a) and 4(3)(f) of this act shall be the
3 Pohnpei Transportation Authority; the allottee of funds
4 appropriated under section 4(3)(h) of this act shall be
5 the Meninkeden Lapalap of Madolenimw and the allottee of
6 funds appropriated under section 4(3)(i) of this act
7 shall be the Luhkenmoanlap of Kitti. The allottee of
8 funds appropriated under subsections 5(1), 5(3) and 5(6)
9 of section 5 of this act shall be the Governor of Chuuk
10 State or his designee. The allottee of funds
11 appropriated under subsection 5(2) of section 5 of this
12 act shall be the Mortlock Islands Development Authority.
13 The allottee of funds appropriated under subsection 5(4)
14 of section 5 of this act shall be the Southern Namoneas
15 Development Authority. The allottee of funds
16 appropriated under subsection 5(5) of section 5 of this
17 act shall be the Faichuk Development Authority. The
18 authority of the allottee to obligate funds appropriated
19 by this act shall lapse on September 30, 2022."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
