3 Government in the amount of \$130,000 for the purpose of funding
4 the Emergency Medical Services for Children Program; and

5 WHEREAS, section 210((2) of title 55 of the Code of the
6 Federated States of Micronesia (Annotated), as amended, requires
7 that for foreign financial assistance to be valid it must be
8 approved by Congress by resolution; and

9 WHEREAS, the FSM Government expressed its appreciation to the
10 Government of the United States for its generosity; now,
11 therefore,

12 BE IT RESOLVED by the Twenty-Second Congress of the Federated
13 States of Micronesia, First Regular Session, 2021, that Congress
14 hereby approves and accepts the \$130,000 grant from the U.S.
15 Department of Health and Human Services to fund the Emergency
16 Medical Services for Children Program, including all the terms and


