

A BILL FOR AN ACT

To appropriate the sum of \$21,327 from the General Fund of the Federated States of Micronesia for the purpose of defraying the operating expenses of the State delegation offices of the Congress of the Federated States of Micronesia for fiscal years 1981 and 1982, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Operating expenses of the State delegation offices of the  
2 Congress. The sum of \$21,327 is hereby appropriated from the General Fund  
3 of the Federated States of Micronesia for the fiscal year ending September 30,  
4 1981, for the purpose of defraying the operating expenses of the State  
5 delegation offices of the Congress of the Federated States of Micronesia.

6 The sum appropriated by this section shall be apportioned as follows:



17 **Section 2. Allotment and responsibility of funds appropriated.** The  
 18 funds appropriated by this act shall be allotted to the Speaker of the  
 19 Congress of the Federated States of Micronesia or his designees, and those  
 20 funds shall be administered and managed in accordance with applicable law,  
 21 including, but not limited to, the Financial Management Act of 1979. The  
 22 authority to obligate funds appropriated by this act shall lapse as of  
 23 September 30, 1982.

1 Section 3. Effective date. This act shall become law upon approval  
2 by the President of the Federated States of Micronesia or upon its becoming  
3 law without such approval.
