

AN ACT

To amend Public Law No. 1-116, as amended by Public Law No. 1-124, to provide supplemental funding for a special session in the State of Truk, and for the operations expenses of the Congress of the Federated States of Micronesia by increasing the amount previously appropriated to \$1,279,688, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-116, as amended by Public
2 Law No. 1-124, is hereby amended to read as follows:

3 "Section 1. Operating expenses of the Office of the Speaker
4 and Members. The sum of \$538,300, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1981, for the purpose of defraying the operating
8 and contingent expenses of the Office of the Speaker and other
9 Members of the Congress of the Federated States of Micronesia.
10 The sum appropriated by this section shall be apportioned as
11 follows:

12	(1) Members' salaries	\$213,000
13	(2) Members' personnel and health benefits. . .	11,000
14	(3) Representation allowance.	5,000
15	(4) Office rental allowance of \$2,400 per	
16	Member.	22,000
17	(5) Members' travel	112,300
18	(6) Standing committees	105,000
19	(7) Official expense allowance of \$5,000 per	
20	Member.	70,000"

21 Section 2. Section 2 of Public Law No. 1-116, as amended by Public
22 Law No. 1-124, is hereby amended to read as follows:

"Section 2. Operating expenses of staff offices of the Congress. The sum of \$591,988, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981, for the purpose of defraying the operating and contingent expenses of staff offices of the Congress and shall be apportioned as follows:

Section 3. Section 3 of Public Law No. 1-116, as amended by Public Law No. 1-124, is hereby amended to read as follows:

"Section 3. Miscellaneous expenses of the Congress. The sum of \$149,400, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1981 for the purpose of defraying miscellaneous expenses of the Congress of the Federated States of Micronesia and shall be apportioned as follows:
