

AN ACT

To amend Public Law No. 2-21, as amended by Public Law No. 2-26, to add a new section 8 thereto; to appropriate the sum of \$1,747,181, for the management and administration of United States Federal programs in the Federated States of Micronesia; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. A new section 8 is hereby added to Public Law No. 2-21,
2 as amended by Public Law No. 2-26, to read as follows:

3 "Section 8. United States Federal programs. The sum of
4 \$1,747,181, which may specifically be made available by the
5 United States for specific programs during fiscal year 1982,
6 is hereby appropriated for management and administration by the
7 executive branch of United States Federal programs, as follows:

9 2-21, as amended by Public Law No. 2-26, are hereby renumbered as
10 sections 9, 10, 11, and 12, respectively.

11 Section 3. This act shall become law upon approval by the Presi-
12 dent of the Federated States of Micronesia or upon its becoming law
13 without such approval.


