

AN ACT

To amend Public Law No. 2-34 appropriating the sum of \$846,200 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-34 is hereby amended to
2 read as follows:

3 "Section 1. The sum of \$846,200, or so much thereof as may be
4 necessary, is hereby appropriated from the General Fund of the
5 Federated States of Micronesia for the fiscal year ending
6 September 30, 1982, for the purpose of funding certain public
7 projects in the State of Truk. The sum appropriated by this
8 section shall be apportioned as follows:

12 Section 2. Section 3 of Public Law No. 2-34 is hereby amended to
13 read as follows:

14 "Section 2. All funds appropriated by this act shall be allot-
15 ted, managed, administered, and accounted for in accordance with
16 applicable law, including, but not limited to, the Financial
17 Management Act of 1979. The allottee shall be responsible for
18 ensuring that these funds, or so much thereof as may be neces-
19 sary, are used solely for the purpose specified in this act, and
20 that no obligations are incurred in excess of the sum appro-
21 priated. The authority of the allottee to obligate funds appro-
22 priated by this act shall lapse as of September 30, 1984."

1 Section 3. This act shall become law upon approval by the Presi-
2 dent of the Federated States of Micronesia or upon its becoming law with-
3 out such approval.
