SECOND REGULAR SESSION, 1983 C.B. No. 3-176, C.D.1, C.D.2

AN ACT

To amend sections 1, 2, 5, 6, and 7 of Public Law No. 3-18 to add positions to and/or appropriate supplemental sums for the Department of External Affairs, the Department of Resources and Development, the Department of Finance, the Office of the Attorney General, the Office of the Budget, the Office of Planning and Statistics, the legislative branch, the Law of the Sea Delegation, and the Micronesian Maritime Authority, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
