A RESOLUTION

Respectfully requesting the Congress of the United States of America to fund the construction of an airstrip on Ta Island, Lower Mortlocks, State of Truk, in fiscal year 1984.

- WHEREAS, the Capital Improvement Program which has been funded
- 2 since fiscal year 1976 is focused on construction projects in the
- 3 former district centers and surrounding areas; and
- WHEREAS, a very high percentage of the Federated States of Micro-
- 5 nesia population lives on outlying islands and in areas which will not
- 6 benefit from prior and current construction projects; and
- WHEREAS, over 10,000 people in the State of Truk reside in the
- 8 Lower Mortlocks, which has been designated a substate center by the
- 9 Truk State Government; and
- 10 WHEREAS, the Lower Mortlocks are currently served by only the
- 11 field trip vessels which are unable to meet the service needs of the
- 12 population for the transportation of mail and passengers, including a
- 13 large number of students; and
- 14 WHEREAS, the welfare of the people of the Lower Mortlocks is
- 15 adversely affected by the lack of a rapid means of transporting
- 16 emergency medical cases and emergency medical supplies; and
- 17 WHEREAS, the people of the Lower Mortlocks have requested that
- 18 an airstrip be built on Ta Island, which is to serve as the
- 19 substate center; now, therefore,
- 20 BE IT RESOLVED by the Third Congress of the Federated States of
- 21 Micronesia, First Regular Session, 1983, that the Congress of the
- 22 Federated States of Micronesia respectfully requests the Congress of
- 23 the United States of America to fund the construction of an airstrip on
- 24 Ta Island, Lower Mortlocks, State of Truk, in fiscal year 1984; and
