A RESOLUTION

Ratifying the Fishing Agreement and the Goods and Services Agreement recently concluded between the Micronesian Maritime Authority and the Federation of Japan Tuna Fisheries Co-operative Associations, the National Offshore Tuna Fisheries Association of Japan, the Japan Far Seas Purse Seine Fishing Association, and the Federation of North Pacific District Purse Seine Fisheries Co-operative Associations of Japan.

- WHEREAS, the Micronesian Maritime Authority concluded on July
- 2 26, 1984, agreements with the Federation of Japan Tuna Fisheries
- 3 Co-operative Associations, the National Offshore Tuna Fisheries Asso-
- 4 ciation of Japan, the Japan Far Seas Purse Seine Fishing Association,
- 5 and the Federation of North Pacific District Purse Seine Fisheries
- 6 Co-operative Associations of Japan, which agreements granted fishing
- 7 rights to said associations in the extended fishery zone of the
- 8 Federated States of Micronesia and further provided for the supply of
- 9 goods and services for the development of fisheries in the Federated
- 10 States of Micronesia; and
- WHEREAS, said agreements require the approval by resolution of
- 12 the Congress of the Federated States of Micronesia, pursuant to 24
- 13 F.S.M.C. 406(1), as amended by Public Law No. 3-10, before they can
- 14 become effective; and
- WHEREAS, the vessels involved in said agreements are more than
- 16 10 vessels; and
- 17 WHEREAS, said agreements will benefit the Federated States of
- 18 Micronesia by generating fisheries revenue and by providing goods
- 19 and services for the development of fisheries in the Federated States
- 20 of Micronesia; now, therefore,
- 21 BE IT RESOLVED by the Third Congress of the Federated States of
- 22 Micronesia, Third Special Session, 1984, that the Congress approves
- 23 and ratifies said agreements; and
- 24 BE IT FURTHER RESOLVED that certified copies of this resolution
- 25 be transmitted to the President of the Federated States of Micronesia,
