## A BILL FOR AN ACT

To further amend Public Law No. 3-48, as amended by Public Law No. 3-69, by amending sections 1 and 5 for the purpose of appropriating the sum of \$350,868 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, as supplemental funding for the Department of Resources and Development, the Office of the Attorney General, the Commission on Future Political Status and Transition, and Postal Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
