A BILL FOR AN ACT

To further amend Public Law No. 3-48, as amended by Public Law No. 3-69, by amending sections 1 and 5 for the purpose of appropriating the sum of \$325,868 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, as supplemental funding for the Department of Resources and Development, the Office of the Attorney General, the Commission on Future Political Status and Transition, and Postal Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-48, as amended by Public
2 Law No. 3-69, is hereby further amended to read as follows:

3 "Section 1. Operating expenses of the executive branch.

4 The sum of ~~\$472,523~~ 716,523, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund of the
6 Federated States of Micronesia, and the sum of \$5,653,915, or
7 so much thereof as may be necessary, is hereby appropriated
8 from the United States Grant Special Fund for the fiscal year
9 ending September 30, 1985, for the operations of the executive
10 branch of the National Government of the Federated States of
11 Micronesia during fiscal year 1985. The sums appropriated by
12 this section shall be apportioned as follows:

6 Section 2. Section 5 of Public Law No. 3-48, as amended by Public
7 Law No. 3-69, is hereby further amended to read as follows:

8 "Section 5. Operating expenses of agencies of the National
9 Government. The sum of ~~\$1,000,000~~ 2,012,564, or so much
10 thereof as may be necessary, is hereby appropriated from the
11 General Fund of the Federated States of Micronesia and the sum
12 of \$312,109, or so much thereof as may be necessary, is hereby
13 appropriated from the United States Grant Special Fund for the
14 fiscal year ending September 30, 1985, for the operations of
15 independent agencies, commissions, authorities, boards,
16 bureaus, and other organizations of the National Government of
17 the Federated States of Micronesia during fiscal year 1985.
18 The sums appropriated by this section shall be apportioned as

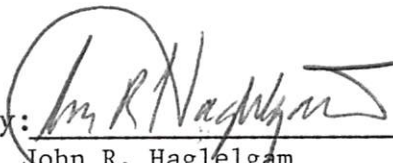
