A BILL FOR AN ACT

To appropriate the sum of \$5,532,912 from the General Fund of the Federated States of Micronesia and the sum of \$6,382,244 from the United States Grant Special Fund for the fiscal year ending September 30, 1986, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1986; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

23	appropriated in each of the paragraphs within the subsections of	
24	section 1.	
25	(2) The Speaker or his designee may reprogram up to 10	

1 percent to and from the funds appropriated to each of the subsections

2 in section 2, and may reprogram up to 15 percent to and from the funds

3 appropriated in each of the paragraphs within the subsections of

4 section 2.

5 (3) The Chief Justice or his designee may reprogram up

6 to 15 percent to and from the funds appropriated in each of the sub-

7 sections in section 3.

8 (4) The Public Auditor may reprogram up to 15 percent to

9 and from the funds appropriated in each of the subsections in section 4.

10 (5) Allottees of funds may reprogram up to 15 percent to

11 and from the funds appropriated in each of the paragraphs within the

12 subsections of section 5.

13 Section 9. Allotment and management of funds and lapse date.

14 All funds appropriated by this act shall be allotted, managed, adminis-

15 tered, and accounted for in accordance with applicable law, including, but

16 not limited to, the Financial Management Act of 1979, as amended. Each

17 allottee shall be responsible for ensuring that these funds, or so much

18 thereof as may be necessary, are used solely for the purposes specified in

19 this act, and that no obligations are incurred in excess of 25 percent of

20 the sums appropriated for each object class; PROVIDED that no equipment

21 over \$50 may be purchased and no new positions may be created. The authority

of the allottees to obligate funds appropriated by this act, except those

23 appropriated by section 5(6) shall lapse as of September 30, 1986.
