A BILL FOR AN ACT

To amend Public Law No. 4-13 by amending section 2 to authorize the President of the Federated States of Micronesia to set an effective date for the Compact of Free Association subject to certain conditions; by adding a new section 3 requiring congressional authorization if the effective date is set for a date prior to termination of the Trusteeship Agreement; by adding a new section 4 relating to implementation conditions; to renumber section 3; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 2 of Public Law No. 4-13 is hereby amended to read as follows: 3 "Section 2. Effective date of the Compact. The President of the Federated States of Micronesia \$1411 16t may agree 4 to an effective date for the Compact of Free Association 5 pursuant to section 411 of the Compact without! (1) Prior consultation with the congress of the 7 redetated states of victoresial and approval by the congress 8 9 by tesplutions and (2) Priot consultation with the State legislatures of 10 11 the redetated states of victonesial and approval by at least three of the four state legislatures by resolution and 12 thereafter implement the Compact, subject to the conditions 13 contained in this act. The President, in establishing and 14 agreeing to an effective date for the Compact, shall 15 consult with the Congress and State governments of the 16 Federated States of Micronesia to ensure that adequate 17 transitional arrangements have been undertaken. " 18 Section 2. Public Law No. 4-13 is hereby amended by the 19 20 addition of a new section 3 to read as follows: "Section 3. Timing of effective date. 21 (1) The President of the Federated States of Micronesia 22 may agree to an effective date for the Compact of Free 23 24 Association which shall occur subsequent to, or concurrent

with, termination of the Trusteeship Agreement for the Former

10	Section 3. Public Law No. 4-13 is hereby amended by the
11	addition of a new section 4 to read as follows:
12	"Section 4. Compact implementation. Implementation of the
13	Compact of Free Association shall be subject to the
14	following conditions:
15	(1) Receipt of a notice of the United States
16	Government's concurrence to the 'Federated States of
17	Micronesia First National Development Plan, 1985-1989'
18	pursuant to section 211(b) of the Compact;
19	(2) Conclusion of the agreements provided for in
20	sections 102(a), 102(b) and 102(c) of U.S. Public Law
21	99-239, completion of the U.S. Congressional review period
22	specified in section 101(f)(2) of U.S. Public Law 99-239
23	with respect to such agreements, and submission of such
24	agreements to the Congress of the Federated States of
25	Micronesia for ratification pursuant to sections 2(b) and 4

2	of Micronesia and to the State legislatures for approval by
3	at least three of the four State legislatures;
4	(3) Conclusion of the agreement provided for in
5	section 111(c) of U.S. Public Law 99-239 and submission of
6	such agreement to the Congress of the Federated States of
7	Micronesia for ratification pursuant to sections 2(b) and 4
8	of article IX of the Constitution of the Federated States of
9	Micronesia and to the State legislatures for approval by at
10	least three of the four State legislatures; and
11	(4) Certification by the President of the Federated
12	States of Micronesia to the Congress of the Federated
13	States of Micronesia that adequate steps have been taken to
L4	ensure full compliance by the Government of the United
15	States of America with the provisions of the 'Agreement
L6	Concerning Procedures for Implementation of United States
L7	Economic Assistance, Programs and Services Provided in the
L8	Compact of Free Association'."
L9	Section 4. Section 3 of Public Law No. 4-13 is hereby renumbered
20	as section 5.
21	Section 5. This act shall become law upon approval by the
22	President of the Federated States of Micronesia or upon its becoming
23	law without such approval.
