A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micro-

1	68 for the purpose of establishing per diem rates for various locations, and for other purposes.
	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Title 52 of the Code of the Federated States of Micro-
2	nesia is hereby further amended by the addition of a new section 167 to
3	read as follows:
4	"Section 167. Payment of travel expenses. Persons travelling
5	on Government business will be reimbursed for their hotel and
6	meal expenses by payment of per diem rates established
7	pursuant to section 2 of this act. Further compensation in
8	the form of an ambassadorial rate may be provided pursuant to
9	regulation.
10	(1) Payment of the per diem rates established by
11	subsections (1) and (2) of section 2 of this act will be paid
12	without provision of receipts.
13	(2) Payment of per diem rates in excess of those
14	set forth in subsection (1) of section 2 of this act but less
15	than the per diem rates set pursuant to subsection (3) of
16	section 2 of this act requires the presentation of receipts

1 1 for expenditures in excess of the rates in subsection (1) of 17 section 2 of this act and such payment shall be no greater 18 than the amount of the receipts presented." 19 Section 2. Title 52 of the Code of the Federated States of Micro-20 nesia is hereby further amended by the addition of a new section 168 21

"Section 168. Establishment of per diem rates. Per diem 23 rates are established as follows: 24 (1) The statutory rates for the specified locations 25

1	are set out below:
2	(a) Kosrae \$ 50.00/day
3	(b) Pohnpei 70.00/day
4	(c) Truk 70.00/day
5	(d) Yap 60.00/day
6	(e) Outer islands
7	(f) New York City 162.00/day
8	(g) Washington, D.C 140.00/day
9	(h) San Francisco, CA 128.00/day
.0	(i) Honolulu, Hawaii 95.00/day
.1	(j) Guam 95.00/day;
.2	(2) The per diem rates for all locations not specified
.3	above shall be set by administrative directive of the
4	President; and
.5	(3) Higher per diem rates for the locations specified
.6	in subsection (1) of this section can be set by
L7	administrative directive of the President, however such
.8	higher rates can only be collected in accordance with the
19	provisions of subsection (2) of section 1 of this act."
20	Section 3. This act shall become law upon approval by the
21	President of the Federated States of Micronesia or upon its becoming
22	law without such approval.
