AN ACT

To further amend Public Law No. 4-11, as amended by Public Laws Nos. 4-12 and 4-21, by amending further sections 1, 2, 4, 5, and 6, as amended by Public Law No. 4-21, for the purpose of appropriating the sum of \$644,707 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, to provide supplemental funding for the Office of the President, the Department of External Affairs, the Office of the Attorney General, the Office of the Public Defender, the legislative branch, the Commission on Future Political Status and Transition, the Foreign Investment Board, and Postal Services; to reapportion funds for the Public Auditor; to fund the Federated States of Micronesia Development Bank; to fund additional National Government subsidies and contributions; and for other purposes.
