A RESOLUTION

Ratifying a treaty entitled "An Arrangement Implementing the Nauru Agreement Setting Forth Minimum Terms and Conditions of Access to the Fishery Zones of the Parties."

- 1 WHEREAS, on February 11, 1982, the Western Pacific nations of
- 2 Papua New Guinea, the Solomon Islands, the Republic of Nauru,
- 3 Kiribati, the Marshall Islands, and the Republic of Palau, along
- 4 with the Federated States of Micronesia, signed the "Nauru Agreement
- 5 Concerning Cooperation in the Management of Fisheries of Common
- 6 Interest, "hereinafter referred to as the "Nauru Agreement"; and
- 7 WHEREAS, the purpose of the "Nauru Agreement" was to ensure that
- 8 the signatory nations cooperate in the management of their respective
- 9 fisheries zones so that their citizens can be assured of receiving the
- 10 maximum benefits from their resource; and
- 11 WHEREAS, the treaty entitled "An Arrangement Implementing the
- 12 Nauru Agreement Setting Forth Minimum Terms and Conditions of Access
- 13 to the Fishery Zones of the Parties," signed on May 2, 1982, is a
- 14 subsidiary agreement to the "Nauru Agreement" and necessary for
- 15 the proper implementation of the "Nauru Agreement"; and
- 16 WHEREAS, the Congress of the Federated States of Micronesia has
- 17 already seen fit to ratify the "Nauru Agreement"; now, therefore,
- 18 BE IT RESOLVED by the Second Congress of the Federated States of
- 19 Micronesia, Fourth Regular Session, 1982, that the treaty entitled
- 20 "An Arrangement Implementing the Nauru Agreement Setting Forth Minimum
- 21 Terms and Conditions of Access to the Fishery Zones of the Parties,"
- 22 as attached hereto be ratified pursuant to the authority granted in
- 23 article IX, section 4, of the Constitution of the Federated States
- 24 of Micronesia; and
