A RESOLUTION

Requesting the United States Secretary of the Department of the Interior to effectuate changes in Secretarial Order No. 3039, amendment No. 1, to allow each of the three constitutional governments of the Trust Territory of the Pacific Islands to assume the operations and administration of their portion of the Trust Territory Social Security System.

- WHEREAS, it is the stated policy of the United States Government
- 2 to terminate the Trusteeship Agreement, which created the Trust
- 3 Territory of the Pacific Islands, and to recognize the Republic of the
- 4 Marshall Islands, the Republic of Palau, and the Federated States of
- 5 Micronesia as self-governing constitutional nations; and
- 6 WHEREAS, the Compact of Free Association has been signed by all
- 7 four Governments; and
- 8 WHEREAS, on the effective date of the Compact of Free Association
- 9 the Trust Territory Social Security System will no longer exist; and
- 10 WHEREAS, it is the intent of the three nations evolving from the
- ll trusteeship to continue the current Social Security System within their
- 12 own nations as a discrete program; and
- 13 WHEREAS, this will require legislative action, administrative
- 14 organization and training, and actuarial activities prior to the trans-
- 15 fer of the apportioned assets of the Trust Territory Social Security
- 16 Trust Fund in a way to adequately assure the continued security of the
- 17 fund; and
- 18 WHEREAS, the United Nations Development Program has provided help
- 19 and assistance in outlining the necessary steps and precautions needed
- 20 to devolve the current system; and
- 21 WHEREAS, the administration of the current Trust Territory Social
- 22 Security System has indicated its willingness to assist in the train-
- 23 ing of personnel and in the orderly transition of responsibilities to
- 24 the constitutional governments; and
- 25 WHEREAS, the Congress of the Federated States of Micronesia has

1 before it legislation to provide for the orderly devolution of its

- 2 share of the Trust Territory Social Security System to the Federated
- 3 States of Micronesia; and
- WHEREAS, Secretarial Order No. 3039, amendment No. 1, requires
- 5 concurrent actions by the three constitutional entities for any
- 6 amendments to the current system and does not provide for the separate
- 7 devolution of the Trust Territory Social Security System to the three
- 8 nations; and
- 9 WHEREAS, time is of the essence to assure an orderly and fiscally
- 10 responsible apportioned transition of the current system to the three
- ll nations comprising the Trust Territory of the Pacific Islands; now,
- 12 therefore,
- BE IT RESOLVED by the Second Congress of the Federated States of
- 14 Micronesia, Fourth Regular Session, 1982, that the Congress requests
- 15 the United States Secretary of the Department of the Interior to
- 16 effectuate changes in Secretarial Order No. 3039, amendment No. 1, to
- 17 allow each of the three constitutional governments of the Trust Terri-
- 18 tory of the Pacific Islands to assume the operations and administration
- 19 of their portion of the Trust Territory Social Security System; and
- 20 BE IT FURTHER RESOLVED that certified copies of this resolution be
- 21 transmitted to the United States Secretary of the Department of the
- 22 Interior, the President of the Republic of the Marshall Islands, the
- 23 President of the Republic of Palau, the High Commissioner of the Trust
