## A RESOLUTION

Respectfully requesting the Speaker of the Congress of the Federated States of Micronesia to appoint a special committee to investigate the activities within the Federated States of Micronesia of foreign corporations and corporations incorporated under Trust Territory law to ensure compliance with Federated States of Micronesia law.

- 1 WHEREAS, certain corporations incorporated under Trust Terri-
- 2 tory law, (hereinafter referred to as TT corporations), do business
- 3 within the Federated States of Micronesia; and
- 4 WHEREAS, some of these TT corporations have their principal
- 5 offices in other jurisdictions within the Federated States of
- 6 Micronesia; and
- 7 WHEREAS, some of the TT corporations do not appear to be in
- 8 compliance with Federated States of Micronesia law; and
- 9 WHEREAS, some of these TT corporations and some foreign corpora-
- 10 tions appear to be paying less than their fair share of taxes in
- 11 the Federated States of Micronesia; and
- 12 WHEREAS, it may be appropriate to change the Federated States
- 13 of Micronesia law to ensure that TT corporations as well as foreign
- 14 corporations pay their fair share of taxes; and
- WHEREAS, some Federated States of Micronesia citizens
- 16 hold stock in the TT corporations and foreign corporations; and
- WHEREAS, some of these corporations have not paid their share-
- 18 holders dividends for several years; and
- 19 WHEREAS, legislation may be appropriate to protect Federated
- 20 States of Micronesia citizens who invest in TT corporations
- 21 and foreign corporations; and
- WHEREAS, Congress has the power to regulate foreign and
- 23 interstate commerce under article IX, section 2, of the Constitution
- 24 of the Federated States of Micronesia; now, therefore,
- 25 BE IT RESOLVED by the Second Congress of the Federated States
