## A BILL FOR AN ACT

To further amend section 2 of Public Law No. 4-51, as amended by Public Laws Nos. 4-88 and 5-1, to appropriate the sum of \$15,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the Congress of the Federated States of Micronesia, and for other purposes.
