## A BILL FOR AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, for the purpose of funding the operations, projects and programs of the Community Action Agencies of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$400,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September 30,
4	1988, for the purpose of funding the operations, projects and programs
5	of the Community Action Agencies of the Federated States of Micronesia.
6	Section 2. The funds appropriated under section 1 of this act
7	shall be apportioned as follows:
8	(1) Truk Community Action Agency \$150,000
9	(2) Pohnpei Community Action Agency 120,000
10	(3) Yap Community Action Agency 65,000
11	(4) Kosrae Community Action Agency

0	(1) Iruk community Action Agency 9130,000
9	(2) Pohnpei Community Action Agency 120,000
10	(3) Yap Community Action Agency 65,000
11	(4) Kosrae Community Action Agency 65,000
12	Section 3. All funds appropriated by this act shall be allotted,
13	managed, administered, and accounted for in accordance with applicable
14	law, including, but not limited to, the Financial Management Act of
15	1979. The allottee for the funds apportioned under subsection (1) of
16	section 2 of this act shall be the executive director of the Truk
17	Community Action Agency. The allottee for the funds apportioned under
18	subsection (2) of section 2 of this act shall be the executive director
19	of the Pohnpei Community Action Agency. The allottee for the funds
20	apportioned under subsection (3) of section 2 of this act shall be
21	the executive director of the Yap Community Action Agency. The
22	allottee for the funds apportioned under subsection (4) of section 2

23 of this act shall be the executive director of the Kosrae Community

24 Action Agency. The allottees shall be responsible for ensuring that

25 these funds, or so much thereof as may be necessary, are used solely

7	law without such approval.
