A BILL FOR AN ACT

To amend title 8 of the Code of the Federated States of Micronesia by repealing sections 101 through 112; to provide for the dissolution of the Commission on Future Political Status and Transition; to provide for the transfer of the functions, personnel, property and funds of the Commission to the executive branch of the National Government of the Federated States of Micronesia; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Dissolution. The Commission on Future Political
- 2 Status and Transition, created by section 101 of title 8 of the Code
- 3 of the Federated States of Micronesia, shall be dissolved 30 days
- 4 after the effective date of this act.
- 5 Section 2. Transfer of functions, personnel, property and
- 6 funds.
- 7 (1) All functions of the Commission on Future Political
- 8 Status and Transition are transferred to and shall be performed by
- 9 the appropriate departments or offices of the executive branch of
- 10 the National Government of the Federated States of Micronesia as
- 11 determined by law or administrative directive of the President.
- 12 (2) All funds held by the Commission shall be transferred
- 13 to the Secretary of Finance for deposit in the General Fund of the
- 14 Federated States of Micronesia. The Secretary of Finance shall have
- 15 the necessary entries made in the accounts of the National Government
- 16 to record outstanding financial rights, liabilities, and obligations
- 17 of the Commission assumed pursuant to subsection (4) of this section.
- 18 (3) Except as otherwise provided by the President of the
- 19 Federated States of Micronesia, the personnel, property and records of
- 20 the Commission shall be transferred to the Department of External
- 21 Affairs of the Federated States of Micronesia, and all unexpended
- 22 and unobligated balances of appropriations for the Commission shall
- 23 be reallotted to such Department for its use in carrying out the
- 24 functions transferred to it pursuant to this section. Any employee

	to the state of th
1	Service System of the Federated States of Micronesia and who is
2	transferred pursuant to this section shall be appointed to a position
3	of the same class or an equivalent class, without any loss of
4	seniority, rights, benefits or privileges held by him prior to such
5	transfer.
6	(4) The executive branch of the National Government of the
7	Federated States of Micronesia shall assume all rights, liabilities
8	and obligations of the Commission, including leases and contractual
9	obligations.
10	Section 3. Repealer. Sections 101 through 112 of title 8
11	of the Code of the Federated States of Micronesia are hereby repealed
12	in their entirety.
13	Section 4. Effective date. This act shall become law upon
14	approval by the President of the Federated States of Micronesia or
15	upon its becoming law without such approval. Sections 2 and 3 of
16	this act shall take effect immediately upon the dissolution of the
17	Commission on Future Political Status and Transition pursuant to
18	section 1 of this act.
