## AN ACT

To further amend Public Law No. 5-52, as amended by Public Laws Nos. 5-55, 5-73 and 5-83, by further amending sections 1, 5 and 14, as amended by Public Law No. 5-83, for the purpose of appropriating the sum of \$265,719 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, as supplemental funding for the executive branch and agencies of the National Government; adjusting employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
