A BILL FOR AN ACT

To amend section 562 of title 58 of the Code of the Federated States of Micronesia, as established by Public Law No. 5-121 and amended by Public Law No. 5-136, for the purpose of providing for limited personal liability on the part of persons participating in the issuance of Bonds, providing conditions for the defense of such persons and the payment of costs of defense, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 562 of title 58 of the Code of the Federated
2	States of Micronesia, as established by Public Law No. 5-121 and
3	amended by Public Law No. 5-136, is hereby further amended to read as
4	follows:
5	"Section 562. Liability of committee members, officers and
6	employees.
7	(1) No member of the committee, officer or employee
8	of the committee, or any officer or employee of the FSM or
9	any political subdivision thereof, including, without
10	limitation, the FSM Attorney General or any person
11	executing any Bonds shall be subject to any personal
12	liability or accountability by reason of the issuance
13	thereof. If, despite the foregoing, any action is brought
14	against any member of the committee, any officer or
15	employee of the committee, or any officer or employee of
16	the FSM, then the FSM shall indemnify, hold harmless and
17	defend such individual against any personal liability or
18	accountability by reason of the issuance of any Bonds.
19	This section shall not apply in the case of fraud or gross

21	(2) Subsection (1) of this section shall not apply to
22	any person covered by subsection (1) of this section who
23	has engaged in fraud or other wanton misconduct relating to
24	the issuance of any Bonds. However, where any person
25	covered in subsection (1) of this section is alleged to

1	have engaged in fraud or other wanton misconduct relating
2	to the issuance of any Bonds, the FSM, upon written request
3	by the person covered in subsection (1) of this section and
4	directed to the FSM Office of the Attorney General, shall
5	provide legal counsel and legal defense for such person at
6	the expense of the FSM. If, upon final judgment, it is
7	established that the person covered by subsection (1) of
8	this section did engage in fraud or other wanton misconduct
9	relating to the issuance of any Bonds, then such person
10	shall reimburse the FSM for costs incurred by the FSM in
11	providing legal counsel and legal defense. If the FSM
12	fails, upon written request, to provide such person with
13	legal counsel and legal defense at FSM expense then the FSM
14	shall be liable to such person for any liability incurred
15	by such person, the cost to such person of legal counsel
16	and legal defense, and subsection (1) of this section shall
17	apply fully to such person."
18	Section 2. This act shall become law upon approval by the
19	President of the Federated States of Micronesia or upon its becoming
20	law without such approval.
