A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-16, 5-88, 5-119, 5-121, and 5-136, by adding a new subchapter VI to chapter 6 for the purpose of establishing the National Commercial Fisheries Fund, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Title 55 of the Code of the Federated States of
2	Micronesia is hereby further amended by adding a new subchapter VI
3	of chapter 6 entitled "National Commercial Fisheries Fund."
4	Section 2. Title 55 of the Code of the Federated States of
5	Micronesia is hereby further amended by adding a new section 650 of
6	subchapter VI of chapter 6 to read as follows:
7	"Section 650. Establishment. There is hereby created
8	and established the National Commercial Fisheries Fund
9	(hereinafter, the 'Fund') which shall be separate from
10	the General Fund of the Federated States of Micronesia
11	and all other funds."
12	Section 3. Title 55 of the Code of the Federated States of
13	Micronesia is hereby further amended by adding a new section 651 of
14	subchapter VI of chapter 6 to read as follows:
15	"Section 651. Purpose. The purpose of the National
16	Commercial Fisheries Fund is to provide for the deposit
17	and disbursement of moneys available for funding the
18	establishment and operations of a commercial fishing and
19	fish processing corporation to be owned and operated, in
20	whole or in partnership, by the National Government of the
21	Federated States of Micronesia."
22	Section 4. Title 55 of the Code of the Federated States of
23	Micronesia is hereby further amended by adding a new section 652
24	of subchapter VI of chapter 6 to read as follows:

"Section 652. Deposits and disbursements. All grant funds

1	received by the National Government of the Federated
2	States of Micronesia on/or after September 1, 1989 from the
3	United States pursuant to section 111 of United States
4	Public Law 99-239 shall be deposited into the Fund;
5	PROVIDED, however, that the aggregate amount of such
6	deposits of principal shall not exceed the amount of
7	\$8,000,000. Additionally, all earnings accrued on
8	the investment of the Fund, and all earnings and
9	revenues collected in connection with the proposed
10	commercial fishing and fish processing activities
11	shall be deposited into the Fund. Moneys available
12	in the Fund shall be withdrawn by the President
13	or his designee for the purposes specified in this
14	subchapter. Any unexpended money in the Fund shall
15	not revert to the General Fund nor lapse at the end
16	of a fiscal year."
17	Section 5. Title 55 of the Code of the Federated States of
18	Micronesia is hereby further amended by adding a new section 653
19	of subchapter VI of chapter 6 to read as follows:
20	"Section 653. Administration. The Fund shall be
21	administered, managed, and accounted for by the President
22	or his designee in accordance with the terms and conditions
23	of this subchapter, the 'Agreement Between the Government of

25	States of Micronesia Regarding the Investment
