A BILL FOR AN ACT

To amend sections 401 and 402 of Public Law No. 2-74, codified as sections 901 and 902 of title 53 of the Code of the Federated States of Micronesia, for the purpose of bringing the Social Security System into financial balance by changing the date when the employee and employer contribution rates both increase to 4 percent of covered earnings to October 1, 1989 from July 1, 1990, and for other purposes.

	BE IT ENA	CTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Sect	ion 1. Section 901 of title 53 of the Code of the Federated
2	States of	Micronesia is hereby amended to read as follows:
3		"Section 901. Employee contributions.
4		(1) There is hereby imposed on every employee a tax
5		equal to the following percentages of wages received by him
6		with respect to employment subject to this subtitle:
7		(a) with respect to wages paid from the
8		effective date of this act through June 30, 1985, the rate
9		shall be two percent;
10		(b) with respect to wages paid from July 1,
11		1985, through June 30% 1990 September 30, 1989, the rate
12		shall be three percent;
13		(c) with respect to wages paid from July 1/ 1990
14		October 1, 1989, through June 30, 1995, the rate shall be
15		four percent;
16		(d) with respect to wages paid from July 1,
17		1995, through June 30, 2000, the rate shall be five percent;
18		(e) with respect to wages paid after June 30,
19		2000, the rate shall be six percent.
20		(2) The tax imposed shall be collected by the
21		employer of the employee by deducting the amount of the tax
22		from the wages as and when paid. Every employer required
23		to so deduct the tax shall be liable for the payment of
24		such tax to the Board and shall be indemnified against the
25		claims and demands of any person for the amount of any such

1		payment made by such employer."
2	Sect	ion 2. Section 902 of title 53 of the Code of the Federated
3	States of	Micronesia is hereby amended to read as follows:
4		"Section 902. Employer contributions. There is hereby
5		imposed on every employer an excise tax, with respect to
6		having an individual in his employ, equal to the following
7		percentages of wages, paid by him with respect to
8		employment subject to this subtitle:
9		(1) with respect to wages paid from the effective
10		date of this act through June 30, 1985, the rate shall be
11		two percent;
12		(2) with respect to wages paid from July 1, 1985,
13		through June 30% 1990 September 30, 1989, the rate shall be
14		three percent;
15		(3) with respect to wages paid from 1414 14 1990
16		October 1, 1989, through June 30, 1995, the rate shall be
17		four percent;
18		(4) with respect to wages paid from July 1, 1995,
19		through June 30, 2000, the rate shall be five percent;
20		(5) with respect to wages paid after June 30, 2000,
21		the rate shall be six percent."
