A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-16, 5-88, 5-119, 5-121 and 5-136, by amending sections 3 and 4 of Public Law No. 2-65, codified as sections 403 and 404 of title 55 of the Code of the Federated States of Micronesia, for the purpose of lowering the dollar value of government contracts required to be let by free and open competitive bidding, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 403 of title 55 of the Code of the Federated States of Micronesia is hereby amended to read as follows: 3 "Section 403. Competitive bidding required. All contracts for construction projects 14/61/14g \$20,000 of 46/4 or 5 for the purchase of personal property involving \$30,000 10,000 or more, made on behalf of any National Government 6 agency shall be let by free and open competitive bidding, 7 8 by sealed bids, to the lowest responsible bidder in 9 accordance with the provisions of this chapter." Section 2. Section 404 of title 55 of the Code of the Federated 10 States of Micronesia is hereby amended to read as follows: 11 12 "Section 404. Citizen-bidder preference - Amount. 13 (1) Citizen bidders who qualify to bid under the provisions of this chapter shall receive preference over 14 noncitizen bidders in determining the award of the contract. 15 (2) For the purpose of determining the preference 16 to be given to citizen bidders, the amount of the bid of 17 each citizen bidder shall be reduced according to the 18 following formula, and such reduction shall be used solely 19 for the purpose of determining the lowest responsible 20 bidder: 21 (a) for all contracts for construction projects 22 involving at least \$20,000 10,000, but less than \$500,000, 23 or for the purchase of personal property involving at least 24 \$50,000 10,000, but less than \$500,000, the amount of the 25

1	bid of each citizen bidder shall be reduced by fifteen percent;
2	(b) for all contracts for construction projects involving
3	at least \$500,000, but less than \$1,500,000, or for the purchase
4	of personal property involving at least \$500,000, but less than
5	\$1,500,000, the amount of the bid of each citizen bidder shall
6	be reduced by ten percent;
7	(c) for all contracts for construction projects involving
8	at least \$1,500,000, but less than \$10,000,000, or for the
9	purchase of personal property involving at least \$1,500,000, but
10	less than \$10,000,000, the amount of the bid of each citizen
11	bidder shall be reduced by five percent; and
12	(d) there shall be no citizen bidder preference with
13	respect to contracts for construction projects involving
14	\$10,000,000 or more, or for the purchase of personal property
15	involving \$10,000,000 or more."
16	Section 3. This act shall become law upon approval by the
17	President of the Federated States of Micronesia or upon its becoming
18	law without such approval.
