A BILL FOR AN ACT

To further amend Public Law No. 5-52, as amended, by further amending sections 12, 13, and 16, as amended by Public Laws Nos. 5-73, 5-90, 5-110, 5-127, and 6-4, for the purpose of correcting the allocation of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 12 of Public Law No. 5-52, as amended by
2	Public Laws Nos. 5-73, 5-110, 5-127 and 6-4, is hereby further amended
3	to read as follows:

10	and refunds of the National Government of the Federated
11	States of Micronesia during fiscal year 1989. The sum
12	appropriated by this section shall be apportioned as follows:

that those funds shall not be transferred from the General 1 Fund to any Community Action Agency until the executive directors have submitted to the Secretary of Finance a copy 3 of their written agreement regarding the distribution of funds among the four agencies. Each allottee shall be 5 responsible for ensuring that these funds, or so much 6 thereof as may be necessary, are used solely for the purposes 7 specified in this act, and that no obligations are incurred 8 9 in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated by this act shall 10 lapse as of September 30, 1989; PROVIDED, however, that the 11 authority of the allottees to obligate funds appropriated 12 by subsection (8) of section 2, by subparagraphs (f) and (g) 13 of subsection (1) of section 12, and by subparagraphs (t) and 14 (u) of subsection (2) of section 12 shall lapse as of 15 September 30, 1990, and, PROVIDED FURTHER, that the 16 authority of the allottees to obligate funds appropriated by 1.7 sections 6, 9, 10 and 13 shall not lapse." 18 19 Section 4.
