A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-16, 5-88, 5-119, 5-121, 5-136 and 6-22, by amending section 216 to prohibit Members of the Congress of the Federated States of Micronesia from becoming allottees of appropriations made by the Congress for public projects, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 216 of title 55 of the Code of the Federated 2 States of Micronesia is hereby amended to read as follows: 3 "Section 216. Allotment of funds - Allottees. Unless otherwise specifically required by law, funds shall be 4 5 allotted as follows: (1) The President of the Federated States of Micronesia, or his designee(s), shall be the allottee of all funds appropriated for the operations or activities of the executive branch of the Federated States of Micronesia 9 10 Government. (2) The Speaker of the Congress of the Federated 11 States of Micronesia, or his designee(s), shall be the 12
 - allottee of all funds appropriated for the operations or activities of the Congress.
 - (3) The Chief Justice of the Supreme Court of the Federated States of Micronesia, or his designee(s), shall be the allottee of all funds appropriated for the operations or activities of the judicial branch of the Federated States of Micronesia Government.
 - (4) The Public Auditor shall be the allottee of all funds appropriated to the Public Auditor.
 - (5) The Governor of a State, or his designee(s), shall be the allottee of all funds appropriated to the State.
