## A BILL FOR AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99 and 5-126, to change the use of certain funds for Chuuk public projects, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 6 of Public Law No. 5-89, as amended by Public
2	Laws Nos. 5-99 and 5-126, is hereby further amended to read as follows:
3	"Section 6. Halls, Western Islands and Namonwitto public
4	projects. The sum of \$200,000, or so much thereof as may be
5	necessary, is hereby appropriated from the General Fund of
6	the Federated States of Micronesia for the fiscal year ending
7	September 30, 1989, for the purpose of funding certain public
8	projects in the Halls, Western Islands and Namonwitto, Truk
9	State. The sum appropriated by this section shall be
10	apportioned as follows:
