A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended by Public Law No. 5-21, by amending sections 168, 169, and 170 to provide for reimbursement by the Government of the Federated States of Micronesia of 50 percent of home leave travel costs of National Government personnel, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

:1	Section 1. Section 168 of title 52 of the Code of the Federated
2	States of Micronesia is hereby amended to read as follows:
3	"Section 168. Government payment prohibited. From the
4	effective date of the act codified in this subchapter, $n\phi$ an
.5	employee or official of the National Government shall be
5	entitled at coverabent expense to reimbursement from the
7	National Government of 50 percent of his transportation
8	costs during his interim-employment period to of and from
9	his home base of any other on a home leave, except tot
13	áccthéa tácátión timé. Such reimbursement shall only be
11	made once every 4 years to any employee or official of
1.2	the National Government."
13	Section 2. Section 169 of title 52 of the Code of the Federated
14	States of Micronesia is hereby amended to read as follows:
15	"Section 169. New-hire and terminated employee trans-
16	portation exempted. This subchapter ptoblibits cotethinent+
17	páid nomé ttánápottátion costs duting the intetimtemplofment
18	petiod and shall not be construed to prohibit full
19	Government-paid transportation costs from an employee's
20	home base to commence his employment with the National
21	Government nor shall it be construed to prohibit full
22	Government-paid transportation costs to an employee's
23	home base after termination of employment with the
24	National Government."
25	Section 3. Section 170 of title 52 of the Code of the Federated

1	States of Micronesia is hereby amended to read as follows:
2	"Section 170. Personnel on contract. Employees or officials
3	entitled by contract existing at the effective date of the
4	act codified in this subchapter to the transportation
5	benefits problibited exceeding those in section 168 of this
6	subchapter shall not be affected by the provisions of section
7	168 of this subchapter for the duration of that contract
8	only. All such contracts entered into after the effective
9	date of the act codified in this subchapter shall conform
LO	to the provisions of this subchapter."
L1	Section 4. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
