## AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding the construction and activities of vocational rehabilitation centers and the activities of the Community Action Agencies in each of the States of Kosrae, Pohnpei, Chuuk and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$400,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September 30,
4	1990, for the purpose of funding the construction and activities of
5	vocational rehabilitation centers and the activities of the Community
6	Action Agencies in each of the States of Kosrae, Pohnpei, Chuuk and
7	Yap.
8	Section 2. The sum appropriated under section 1 of this act
9	shall be apportioned as follows:
10	(1) Activities of the Community Action Agencies
11	in each of the States \$300,000
12	(2) Kosrae Vocational Rehabilitation Center 25,000
13	(3) Pohnpei Vocational Rehabilitation Center 25,000
14	(4) Chuuk Vocational Rehabilitation Center 25,000
15	(5) Yap Vocational Rehabilitation Center 25,000
16	Section 3. All funds appropriated by this act shall be allotted,
17	managed, administered, and accounted for in accordance with applicable
18	law, including, but not limited to, the Financial Management Act of
19	1979. The allottees for the funds appropriated under subsection (1)
20	of section 2 of this act shall be the executive directors of the four
21	State Community Action Agencies. The allottees for the funds

2	Each allottee shall be responsible for ensuring that these funds, or
3	so much thereof as may be necessary, are used solely for the purposes
4	specified in this act, and that no obligations are incurred in excess
5	of the sum appropriated; PROVIDED, however, that no funds shall be
6	transferred from the General Fund to any Community Action Agency
7	until the executive directors have submitted to the Secretary of
8	Finance a copy of their written agreement regarding the distribution
9	of funds among the four agencies. The authority of the allottees
