

## AN ACT

To further amend Public Law No. 5-52, as amended, by further amending sections 1, 7, 12, 13, and 16, as amended by Public Laws Nos. 5-73, 5-83, 5-90, 5-101, 5-106, 5-110, and 5-127, for the purpose of appropriating the sum of \$891,366 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, as supplemental funding for the executive branch, National Government programs, grants, subsidies, contributions, and refunds, and development budget; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 5-52, as amended by Public  
2 Laws Nos. 5-83, 5-106 and 5-127, is hereby further amended to read as  
3 follows:

4           "Section 1. Operating expenses of the executive branch.

5           The sum of \$9,186,147, or so much thereof as may be  
6           necessary, is hereby appropriated from the General Fund  
7           of the Federated States of Micronesia for the fiscal year  
8           ending September 30, 1989, for the operations of the  
9           executive branch of the National Government of the Federated  
10          States of Micronesia during fiscal year 1989. The sum  
11          appropriated by this section shall be apportioned as follows:

23 program. The sum of \$304,568, or so much thereof as may be  
24 necessary, is hereby appropriated from the General Fund of  
25 the Federated States of Micronesia for the fiscal year

1 ending September 30, 1989, for the purpose of funding a  
2 program of marine surveillance during fiscal year 1989. The  
3 funds appropriated under this section shall be deemed to  
4 come from the funds available under section 216(a)(1) of the  
5 Compact of Free Association. The sum appropriated by this  
6 section shall be apportioned as follows:

12 Section 3. Section 12 of Public Law No. 5-52, as amended by

16 subsidies, contributions, and refunds. The sum of  
17 \$2,792,355, or so much thereof as may be necessary, is  
18 hereby appropriated from the General Fund of the Federated  
19 States of Micronesia for the fiscal year ending September 30,  
20 1989, for special programs, grants, subsidies, contributions,  
21 and refunds of the National Government of the Federated  
22 States of Micronesia during fiscal year 1989. The sum  
23 appropriated by this section shall be apportioned as follows:

23 Section 5. Section 16 of Public Law No. 5-52 is hereby amended  
24 to read as follows:  
25 "Section 16. Allotment and management of funds and lapse

1           date. All funds appropriated by this act shall be allotted,  
2           managed, administered, and accounted for in accordance with  
3           applicable law, including, but not limited to, the Financial  
4           Management Act of 1979, as amended; PROVIDED, however, that  
5           the allottees for funds appropriated under subparagraph (p)  
6           of subsection (2) of section 12 shall be the executive  
7           directors of the four State Community Action Agencies, and  
8           that those funds shall not be transferred from the General  
9           Fund to any Community Action Agency until the executive  
10          directors have submitted to the Secretary of Finance a copy  
11          of their written agreement regarding the distribution of  
12          funds among the four agencies. Each allottee shall be  
13          responsible for ensuring that these funds, or so much  
14          thereof as may be necessary, are used solely for the purposes  
15          specified in this act, and that no obligations are incurred  
16          in excess of the sum appropriated. The authority of the  
17          allottees to obligate funds appropriated by this act shall  
18          lapse as of September 30, 1989; PROVIDED, however, that the  
19          authority of the allottees to obligate funds appropriated  
20          by subsection (8) of section 2, by subparagraph (f) of  
21          subsection (1) of section 12, and by subparagraph (t) of  
22          subsection (2) of section 12 shall lapse as of September 30,  
23          1990, and, PROVIDED FURTHER, that the authority of the  
24          allottees to obligate funds appropriated by sections 6, 9,  
25          10 and 13 shall not lapse."

1       Section 6. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its becoming  
3 law without such approval.
