AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 216 for the purpose of authorizing certain officials to designate allottees in certain circumstances, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 216 of title 55 of the Code of the Federated
2	States of Micronesia is hereby amended to read as follows:
3	"Section 216. Allotment of funds - Allottees.
4	(A) Unless otherwise specifically required by law,
5	funds shall be allotted as follows:
6	(1) The President of the Federated States of
7	Micronesia, or his designee(s), shall be the allottee of
8	all funds appropriated for the operations or activities of
9	the executive branch of the Federated States of Micronesia
10	Government.
11	(2) The Speaker of the Congress of the Federated
12	States of Micronesia, or his designee(s), shall be the
13	allottee of all funds appropriated for the operations or
14	activities of the Congress.
15	(3) The Chief Justice of the Supreme Court of
16	the Federated States of Micronesia, or his designee(s),
17	shall be the allottee of all funds appropriated for the
18	operations or activities of the judicial branch of the
19	Federated States of Micronesia Government.
20	(4) The Public Auditor shall be the allottee of
21	all funds appropriated to the Public Auditor.
22	(5) The Governor of a State, or his designee(s),

1	shall be the allottee of all funds appropriated to the
2	State.
3	(6) The President of the Federated States of
4	Micronesia, or his designee(s), shall be the allottee of
5	any funds appropriated for any activity, entity, or person
6	not included within the provisions of paragraphs (1) through
7	(5) of this subsection.
8	(B) Unless specifically prohibited by law, whenever
9	the President of the Federated States of Micronesia, the
10	Speaker of the Congress of the Federated States of
11	Micronesia, the Chief Justice of the Supreme Court of the
12	Federated States of Micronesia or the Governor of a State
13	is named as the allottee, such official may designate as
14	the allottee another officer who is subject to his
15	supervision and control."
16	Section 2. This act shall become law upon approval by the
17	President of the Federated States of Micronesia or upon its becoming
18	law without such approval.
