Public Law No. 6 - 88

AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding public projects in the Mortlocks Islands of Chuuk State, and for other purposes.

12	Section 5. All funds appropriated by this act shall be						
13	allotted, managed, administered, and accounted for in accordance with						
14	applicable law, including, but not limited to, the Financial						
15	Management Act of 1979. The allottee of the funds appropriated by						
16	section 1 of this act shall be the Upper Mortlocks Authority; the						
17	allottee of the funds appropriated by section 2 of this act shall be						
18	the Mid-Mortlocks Authority; and the allottee of the funds						
19	appropriated by sections 3 and 4 of this act shall be the Lower						
20	Mortlocks Authority. The allottees shall be responsible for ensuring						
21	that these funds, or so much thereof as may be necessary, are used						
22	solely for the purposes specified in this act, and that no						
23	obligations are incurred in excess of the sum appropriated. The						
24	authority of the allottees to obligate funds appropriated by this act						
25	shall not lapse until expended.
