AN ACT

To further amend Public Law No. 6-49, as amended by Public Law No. 6-55, by further amending sections 1 and 10, as amended by Public Law No. 6-55, to change the use of funds appropriated thereunder, and to designate an allottee for a new project, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1	. Sec	ction 1 of Public Law No. 6-49, as	amended by

4	Section 2. Section 10 of Public Law No. 6-49, as amended by
5	Public Law No. 6-55, is hereby further amended to read as follows:
6	"Section 10. Allotment and management of funds and lapse
7	date. All funds appropriated by this act shall be
8	allotted, managed, administered, and accounted for in
9	accordance with applicable law, including, but not limited
10	to, the Financial Management Act of 1979. The allottee of
11	the funds appropriated by section 4 of this act shall be
12	the President of the Federated States of Micronesia. The
13	allottee of the funds appropriated by subsection (2) of
14	section 1 of this act shall be the Truk Organization of
15	Community Action (TOCA); the allottee of the funds
16	appropriated by subsection (4) of section 1 shall be the
17	Lower Mortlocks Development Authority; and the allottee of
18	the funds appropriated by subsections (1), (3), (5), (6),
19	(7), (8), (9), (10), and (11) of section 1 shall be
20	the Governor of Chuuk State. The allottee of the funds
21	appropriated under subsection (12) of section 1 of this act
22	shall be the Peace Corps Representative, Chuuk State. The
23	allottees of the funds appropriated by sections 2, 3, 5, 6,
24	7, 8 and 9 of this act shall be the local development
25	authorities of the areas for which the projects are

1	designated. The allottees shall be responsible for
2	ensuring that these funds, or so much thereof as may be
3	necessary, are used solely for the purposes specified in
4	this act, and that no obligations are incurred in excess of
5	the sum appropriated. The authority of the allottees to
6	obligate funds appropriated by this act shall not lapse
7	until expended."
8	Section 3. This act shall become law upon approval by the
9	President of the Federated States of Micronesia or upon its becoming
10	law without such approval.
