- 13 \$250,000 for each deployed team to support the cost of the Civic

- 13 WHEREAS, the Civic Action Teams are supposed to assist the
- 16 Covernment of the Federated States of Micronesia with development
- 17 projects and provide training and apprenticeship opportunities
- 18 for FSH citizens; and
- 19 WHEREAS, the Civic Action Teams operative in the FSM have not
- 20 provided the level of assistance anticipated by the Government of the
- 21 Federated States of Micronepla; and
- 22 MEPPAS, it is the sense of the Congress that the Government of
- 23 the Federated States of Micronesia can utilize the \$250,000 now apant
- 24 for Civil Action Temps for more beneficial endeavors; and
- The ADDREAS, pursuant to Amex B of the Agreement concluded
