A BILL FOR AN ACT

To further amend Public Law No. 5-85, Chuuk State public projects, as amended by Public Laws Nos. 6-7, 6-29 and 7-21, by further amending section 2, as amended by Public Law No. 7-21, to modify the use of certain funds appropriated therein; by further amending section 3, as amended by Public Laws Nos. 6-7, 6-29 and 7-21, to change the allottee of certain funds appropriated therein; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 5-85, as amended by
2	Public Law No. 7-21, is hereby further amended to read as follows:
3	"Section 2. The sum appropriated under section 1 of this
4	act shall be apportioned as follows:
5	(1) Ta Airport project
6	(a) Relocation of schoolroom away from
7	runway area\$30,000
8	(b) Engineering and initial construction
9	expenses for a causeway between Ta and Satawan 40,000 20,000
10	(2) Ulul Airport project 40,000
11	(3) Oneop Ice Plant lease 10,000
12	(4) National and State CIP project inspection
13	costs
14	Section 2. Section 3 of Public Law No. 5-85, as amended by Public
15	Laws Nos. 6-7, 6-29 and 7-21, is hereby further amended to read as
16	follows:
17	"Section 3. All funds appropriated by this act shall be
18	allotted, managed, administered, and accounted for in
19	accordance with applicable law, including, but not limited
20	to, the Financial Management Act of 1979. The allottee of
21	the funds appropriated by subsections (1) , (3) and (4) of
22	section 2 of this act shall be the Lower Mortlocks Development
23	Authority. The allottee of the funds appropriated by
24	subsection (2) of section 2 of this act shall be the
25	President of the Federated States of Micronesia. Each

1	allottee shall be responsible for ensuring that these
2	funds, or so much thereof as may be necessary, are used
3	solely for the purposes specified in this act, and that no
4	obligations are incurred in excess of the sum
5	appropriated. The authority of the allottees to obligate
6	funds appropriated by this act shall not lapse until
7	expended."
8	Section 3. This act shall become law upon approval by the
9	President of the Federated States of Micronesia or upon its becoming
10	law without such approval.
