AN ACT

To appropriate the sum of \$3,259,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of constructing and/or improving roads and/or airports in the four States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$1,300,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the 2 Federated States of Micronesia for the fiscal year ending September 30, 3 1993, for the purpose of constructing and/or improving roads and/or airports in Chuuk State. The funds appropriated under this section are to be expended only if they have first been matched by the State 6 and/or municipal governments of Chuuk State. The sum appropriated 7 under this section shall be apportioned as follows: 8 (1) Faichuk \$300,000 9 10 (2) Southern Namoneas 400,000 (3) Northern Namoneas 200,000 11 (4) Mortlocks 12 200,000 13 (5) Western, Namonuito and Hall Islands.. Section 2. The sum of \$200,000, or so much thereof as may be 14
- necessary, is hereby appropriated from the General Fund of the 15

Federated States of Micronesia for the fiscal year ending September 30,

- 1993, for the purpose of constructing and/or improving roads and/or 17

| 15 | State. The allottee of the funds appropriated under subsection (2) |
| 16 | of section 6 of this act shall be the Chief Executive Officer of |
| 17 | Kitti Municipality, Pohnpei State. The allottees shall be responsible |
| 18 | for ensuring that these funds, or so much thereof as may be necessary, |
| 19 | are used solely for the purposes specified in this act, and that no |
| 20 | obligations are incurred in excess of the sum appropriated. The |
| 21 | authority of the allottees to obligate funds appropriated by this act |
| 22 | shall lapse as of September 30, 1994. |
