AN ACT

To amend Public Law No. 7-24, Pohnpei State public projects, by amending section 1 to allocate the funds appropriated therein, by amending section 2 to modify the allottee of the funds appropriated therein, by adding new sections 2, 3 and 4 to allocate the funds appropriated therein, by renumbering section 3, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-24 is hereby amended

10	Section 5. Section 2 of Public Law No. 7-24 is hereby amended
11	to read as follows:
12	"Section 5. All funds appropriated by this act shall be
13	allotted, managed, administered, and accounted for in
14	accordance with applicable law, including, but not limited
15	to, the Financial Management Act of 1979. The allottee of
16	the funds appropriated under subsections (2) , (4) , (6) , (7) ,
17	(8), (9), (10), (11), (12), (13), (14) and (15) of section
18	1 of this act, and of sections 2 and 3 of this act, shall
19	be the President of the Federated States of Micronesia.
20	The allottee of the funds appropriated under section 4 of
21	this act shall be the Governor of Pohnpei State. The
22	allottee of the funds appropriated under subsection (1) of
23	section 1 of this act shall be the Pohnpei State PTA. The
24	allottee of the funds appropriated under subsection (3) of
25	section 1 of this act shall be the Chief Magistrate of

1	Sokehs Municipality. The allottee of the funds appropriated
2	under subsection (5) of section 1 of this act shall be the
3	Luhkenkolwof of Sapwuahfik Municipality. The allottees
4	shall be responsible for ensuring that these funds, or so
5	much thereof as may be necessary, are used solely for the
6	purposes specified in this act, and that no obligations
7	are incurred in excess of the sum appropriated. The
8	authority of the allottees to obligate funds appropriated
9	by this act shall not lapse."
10	Section 6. Section 3 of Public Law No. 7-24 is hereby
11	renumbered as section 6.
12	Section 7. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its becoming
14	law without such approval.
