AN ACT

To further amend Public Law No. 6-89, Kosrae State public projects, as amended by Public Laws Nos. 7-7, 7-48 and 7-51, by further amending section 2, as amended by Public Law No. 7-7, to modify the use of certain funds previously appropriated therein, and by further amending section 3, as amended by Public Laws Nos. 7-7, 7-48 and 7-51, to modify the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

10	"Section 3. All funds appropriated by this act shall be
11	allotted, managed, administered, and accounted for in
12	accordance with applicable law, including, but not limited
13	to, the Financial Management Act of 1979. The allottee of
14	the funds appropriated under subsections (1) and (5),
15	except paragraph (a) of subsection (5), of section 2 of
16	this act, and paragraphs $(3)(c)$, $(3)(d)$, $(3)(e)$, $(3)(f)$,
17	(3)(g), $(3)(h)$, $(4)(a)$, $(4)(b)$, $(4)(d)$, $(4)(e)$, $(4)(f)$ and
18	(4)(g) of section 2 of this act shall be the Chairman of
19	the KSCIP. The allottee of the funds appropriated under

2	appropriated under paragraph (4)(c) of section 2 of this
3	act shall be the Mayor of Malem Municipality. The allottee
4	of the funds appropriated under subsection (6) of section 2
5	of this act shall be the Chairman of the Kosrae
6	Congressional Delegation. The allottees shall be
7	responsible for ensuring that these funds, or so much
8	thereof as may be necessary, are used solely for the
9	purposes specified in this act, and that no obligations are
LO	incurred in excess of the sum appropriated. The authority
11	of the allottees to obligate funds appropriated by this act
12	shall not lapse until expended."
13	Section 3. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
