## AN ACT

To appropriate the sum of \$2,565,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, of which amount \$500,000 shall be deemed to come from the funds available under Compact section 221(b), for the purpose of funding elementary and secondary education needs in each of the States and certain other educational needs in the States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2	The sum of \$915,000, or so much thereof as may be necessary, is hereby

15	purpose of funding elementary and secondary education needs in Kosrae
16	State. The sum appropriated under this section shall be apportioned
17	as follows:

16	Section 5. All funds appropriated by this act shall be allotted,
17	managed, administered, and accounted for in accordance with applicable
18	law, including, but not limited to, the Financial Management Act of
19	1979. The allottee of the funds appropriated under subsections (1)
20	and (2) of section 1 of this act shall be the respective school board
21	of each institution; the allottee of the funds appropriated under
22	subsection (4) of section 1 of this act shall be the Southern
23	Namoneas Development Authority; the allottee of the funds
24	appropriated under subsection (5) of section 1 of this act shall be
25	the President of the Federated States of Micronesia or the President's

1 designee; and the allottee of the remaining subsections of section 1 shall be the Governor of Chuuk State. The President or the President's designee shall be the allottee of the funds appropriated 3 under sections 2 and 4 of this act. The allottee of the funds 5 appropriated under subsections (1) and (3) of section 3 of this act shall be the Governor of Pohnpei State or his designee. The allottee of the funds appropriated under subsections (2) and (4) of section 3 of this act shall be the Pohnpei Community Action Agency. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose 10 11 specified in this act, and that no obligations are incurred in excess 12 of the sum appropriated. The authority of the allottees to obligate 13 funds appropriated by this act shall lapse as of September 30, 1994. Section 6.
