

A BILL FOR AN ACT

To further amend Public Law No. 7-117, as amended by Public Law No. 7-136, by further amending section 6, as amended by Public Law No. 7-136, for the purpose of modifying the uses of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 7-117, as amended by Public Law No. 7-136, is hereby further amended to read as follows:

"Section 6. The sum of \$500,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of constructing and/or improving roads and power distribution systems in the Kitti and Madolenihmw Municipalities in Pohnpei State. The sum appropriated under this section shall be apportioned as follows:
