## A BILL FOR AN ACT

To further amend Public Law No. 5-42, as amended by Public Laws Nos. 5-62, 6-13 and 7-49, by further amending section 2, as amended by Public Law No. 5-62, to change the use of funds previously appropriated therein; by further amending section 3, as amended by Public Laws Nos. 5-62, 6-13 and 7-49, to change the allottee of funds appropriated therein; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 2 of Public Law No. 5-42, as amended by Public
2	Law No. 5-62, is hereby further amended to read as follows:
3	"Section 2. The sum appropriated under section 1 of this
4	act shall be apportioned as follows:
5	(1) Mutunnenea to Sialat Road\$ 40,000
6	(2) PIIYW4I ¥Ø TAF IMM#¥ RØAØ///////////////////////////////////
7	(2) Malem Farm Road
8	(3) Utwe Farm Road
9	(34) Kosrae Community Action Program 10,000"
10	Section 2. Section 3 of Public Law No. 5-42, as amended by Public Law
11	Nos. 5-62, 6-13 and 7-49, is hereby further amended to read as follows:
12	"Section 3. All funds appropriated by this act shall be
13	allotted, managed, administered, and accounted for in
14	accordance with applicable law, including, but not limited to,
15	the Financial Management Act of 1979. The allottee of the
16	funds appropriated under subsections (1) and $(34)$ of section 2
17	of this act shall be the Governor of Kosrae State. The allottee
18	of the funds appropriated under subsection (2) of section 2 of
19	this act shall be the $C$ MA $I$ I $\phi$ M $\phi$ F $\phi$ M $\phi$ F $\phi$ M $\phi$ F Mayor of Malem.
20	The allottee of the funds appropriated under subsection (3) of
21	section 2 of this act shall be the Mayor of Utwe. The allottees
22	shall be responsible for ensuring that these funds, or so much
23	thereof as may be necessary, are used solely for the purpose
24	specified in this act, and that no obligations are incurred in
25	excess of the sum appropriated. The authority of the allottees

1	to obligate funds appropriated by this act shall not lapse until
2	fully expended."
3	Section 3. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its becoming
5	law without such approval.
