A BILL FOR AN ACT

To appropriate the sum of \$126,200 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, and to amend section 14 of Public Law No. 8-18 for the purpose of hiring a local counterpart and secretary in banking regulation, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$126,200, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of
- 3 the Federated States of Micronesia for the fiscal year ending
- 4 September 30, 1994, for the purpose of paying the salary,
- 5 housing allowance, and related expenses of a local counterpart
- 6 and secretary to work with an in-house expert provided by the
- 7 IMF/World Bank Group for a period of two years in the area of
- 8 banking regulation. It is anticipated that said local
- 9 counterpart will eventually become a Commissioner of Banking for
- 10 the Federated States of Micronesia.
- 11 Section 2. Section 14 of Public Law No. 8-18 is hereby
- 12 amended to read as follows:
- "Section 14. <u>Employment ceilings</u>. Subsection (1) sets forth the maximum number of positions that may be hired by branches and agencies of the National Government.
- 16 (1) Positions funded for fiscal year 1994.

5	for unbudgeted positions."		
6	Section 3. All funds appropriated by this act shall be		
7	allotted, managed, administered, and accounted for in accordance		
8	with applicable law, including, but not limited to, the		
9	Financial Management Act of 1979. The allottee shall be		
10	responsible for ensuring that these funds, or so much thereof as		
11	may be necessary, are used solely for the purpose specified in		
12	this act, and that no obligations are incurred in excess of the		
13	sum appropriated. The authority of the allottee to obligate		
14	funds appropriated by this act shall lapse as of September 30,		
15	1996.		
16	Section 4. This act shall become law upon approval by the		
17	President of the Federated States of Micronesia or upon its		
18	becoming law without such approval.
