A BILL FOR AN ACT

To appropriate the sum of \$40,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, for the purpose of funding the acquisition of boxes and/or other shipping material and to make such materials available at no charge for the export of agricultural products from the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$40,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1994, for the purpose of funding the acquisition of boxes and/or
5 other shipping material for the export of agricultural products from
6 the State of Kosrae. Materials purchased pursuant to this appro-
7 priation shall be made available at no charge to farmers, farmers'
8 cooperatives and locally-based businesses in the State of Kosrae
9 through the Kosrae State Department of Conservation and Development.

10 Section 2. All funds appropriated by this act shall be allotted,
11 managed, administered, and accounted for in accordance with
12 applicable law, including, but not limited to, the Financial
13 Management Act of 1979. The allottee shall be the President of the
14 Federated States of Micronesia or the President's designee. The
15 allottee shall be responsible for ensuring that these funds, or so
16 much thereof as may be necessary, are used solely for the purpose
17 specified in this act, and that no obligations are incurred in excess
18 of the sum appropriated. The authority of the allottee to obligate
19 funds appropriated by this act shall not lapse.

20 Section 3. This act shall become law upon approval by the
21 President of the Federated States of Micronesia or upon its
22 becoming law without such approval.

A BILL FOR AN ACT
