A BILL FOR AN ACT

To further amend Public Law No. 7-117, as amended by Public Laws Nos. 7-136, 8-11 and 8-14, by further amending section 8, as amended by Public Law No. 7-136, for the purpose of changing the allottee with respect to certain projects within the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Т	Section 1. Section 8 of Public Law No. 7-117, as amended by
2	Public Law No. 7-136, is hereby further amended to read as follows:
3	"Section 8. All funds appropriated by this act shall be
4	allotted, managed, administered, and accounted for in
5	accordance with applicable law, including, but not limited
6	to, the Financial Management Act of 1979. The allottee of
7	the funds appropriated under subsections (1), and (2) and
8	(4) of section 1 of this act shall be the President of the
9	Federated States of Micronesia. The allottee of the funds
10	appropriated under subsection (3) of section 1 of this act
11	shall be the Lower Mortlocks Development Authority. The
12	allottee of the funds appropriated under paragraph (4)(a) of
13	section 1 shall be the Hall Islands Development Authority,
14	and the allottee of the funds appropriated under paragraph
15	(4)(b) of section 1 shall be the Pattiw Development
16	Authority. The allottee of the funds appropriated under
17	section 2 of this act shall be the Chairman of the KSCIP.
18	The allottee of the funds appropriated under subsection (1)
19	of section 3 of this act shall be the Pohnpei Port
20	Authority. The allottee of the funds appropriated under
21	subsection (2) of section 3 of this act shall be the
22	Pohnpei Community Action Agency. The allottee of the funds
23	appropriated under subsection (1) of section 5 of this act
24	shall be the Pohnpei Transportation Authority. The
25	allottee of the funds appropriated under subsection (2) of

1	section 5 of this act shall be the Pohnpei Community Action
2	Agency. The allottee of the funds appropriated under
3	subsection (1) of section 6 of this act shall be the Chief
4	Executive Officer of Madolenihmw Municipality, Pohnpei
5	State. The allottee of the funds appropriated under
6	subsection (2) of section 6 of this act shall be the
7	Chief Executive Officer of Kitti Municipality, Pohnpei
8	State. The allottee of the funds appropriated under
9	section 7 of this act shall be the PWP Development
10	Authority. The allottees shall be responsible for ensuring
11	that these funds, or so much thereof as may be necessary,
12	are used solely for the purposes specified in this act, and
13	that no obligations are incurred in excess of the sum
14	appropriated. The authority of the allottees to obligate
15	funds appropriated by this act shall lapse as of September
16	30, 1994."
17	Section 2. This act shall become law upon approval by the
18	President of the Federated States of Micronesia or upon its becoming
19	law without such approval.
