A BILL FOR AN ACT

To further amend Public Law No. 7-117, as amended, by further amending section 8, as amended by Public Laws Nos. 7-136, 8-20, 8-42, 8-50 and 8-84, to modify the allottee of certain funds appropriated therein, to adjust lapse dates, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 8 of Public Law No. 7-117, as amended by
2	Public Laws Nos. 7-136, 8-20, 8-42, 8-50 and 8-84, is hereby further
3	amended to read as follows:
4	"Section 8. All funds appropriated by this act shall be
5	allotted, managed, administered, and accounted for in
6	accordance with applicable law, including, but not limited
7	to, the Financial Management Act of 1979. The allottee
8	of the funds appropriated under subsections (1) and (2)
9	of section 1 of this act shall be the President of the
0	Federated States of Micronesia. The allottee of the funds
1	appropriated under subsection (4)(a) of section 1 of
2	this act shall be the Hall Islands Development Authority.
3	The allottee of the funds appropriated under subsections
4	(4) (b) and (4) (c) of section 1 of this act shall be the
5	Pattiw Social and Economic Development Authority. The
6	allottee of the funds appropriated under subsection (3)
7	of section 1 of this act shall be the Lower Mortlocks
8	Development Authority. The allottees of the funds
9	appropriated under subsections (1), (2), (3), and (4) of
20	section 2 of this act shall be the Mayors of Lelu,
21	Tafunsak, Malem, and Utwe, respectively. The allottees by
22	the fynds appropriated under paragraphs (5)(a) and (b)
23	of section 2 of this act shall be the Mayors of Levy and
24	MAIdIN/ 145pectively. The allottee of the funds
25	appropriated under paragraph (5) (a) of section 2 of

1 this act shall be the Mayor of Lelu. The allottee of the funds appropriated under paragraph (5)(b) of section 2 2 of this act shall be the FSM National Revenue Officer. 3 Kosrae State. The allottee of the funds appropriated 4 under subsection (1) of section 3 of this act shall be the 5 Pohnpei Port Authority. The allottee of the funds 6 appropriated under subsection (2) of section 3 of this 7 act shall be the Pohnpei Community Action Agency. The 8 allottee of the funds appropriated under section 4 of this 9 act shall be Governor of the State of Yap. The allottee of 10 the funds appropriated under subsection (1) of section 5 11 of this act shall be the Pohnpei Transportation Authority. 12 13 The allottee of the funds appropriated under subsection (2) of section 5 of this act shall be the Pohnpei 14 Community Action Agency. The allottee of the funds 15 appropriated under subsection (1) of section 6 of this 16 act shall be the Chief Executive Officer of Madolenihmw 17 Municipality, Pohnpei State. The allottee of the funds 18 appropriated under subsection (2) of section 6 of this 19 20 act shall be Chief Executive Officer of Madolenihmw Municipality, Pohnpei State. The allottee of the funds 21 appropriated under subsection (2) of section 6 of this 22 act shall be the Chief Executive Officer of Kitti Municipality, 23 Pohnpei State. The allottee of the funds appropriated 24 25 under section 7 of this act shall be PWP Development

1	Authority. The allottees shall be responsible for ensuring
2	that these funds, or so much thereof as may be
3	necessary, are used solely for the purposes specified in
4	this act, and that no obligations are incurred in excess of
5	the sum appropriated. The authority of the allottees to
6	obligate funds appropriated by this act shall lapse as of
7	September 30, 1994, except that the authority of the
8	allottees to obligate funds appropriated by section 2 and
9	section 4 of this act shall not lapse as of Septender 304
10	1995/ and the authority of the allottee to obligate funds
11	appropriated by section 4 of this act shall not lapse."
12	Section 2. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its becoming
14	law without such approval.
